Opened Station #2 on US HWY 183 in Briggs, New command/First responder vehicle into service, Put new 3000 gallon Engine/Tender into service, ,Acquired Rescue/Engine from SW Bell Fire and put into service, Added 38K gallon water storage tank with 555gpm truck filing pump at Watson, Upgraded communication equipment, Upgraded rainwater collection water system truck filling pump at station 1 from 100gpm tp 500gpm. New EMT basics on staff, 2 auto pulse compression devices in commander/First responder vehicles,Installed new SCBA bottle fill cascade system, put

into service a can am 6x6 with skid unit and stokes basket for wildland fir and rescue operations, implemented a recruiting campaign, 3 new fire fighters, Implemented New Cad System

B.32 calls, Average response time was 8 minutes, excluding mutual aid. Average Responders was 7. 16 medical assists, and 3 grass fires. Four trainings were offered for firefighters 1 course, Apparatus and driver and debrief policies and department policies. Total hours 10.
