

**INVITATION TO BID  
"18-614-01" ASPHALT PAVER**

**INTENT:** It is the intent of this Invitation to Bid to establishing pricing for a new asphalt paver and trailer delivered to specified site 110 CR 424, Marble Falls, Texas 78654.

**DUE DATE:** WEDNESDAY, JANUARY 17<sup>TH</sup> AT 3:00P.M.at which time the bids will be publicly opened and read aloud in the Burnet County Auditor's Conference Room located at 133 East Jackson Street, Burnet, Texas 78611.

**INSTRUCTION TO BIDDERS:** Sealed bids must be received in the Office of the Purchasing Agent on or before the time and date specified, whether hand delivered or mailed will not be considered and returned unopened to sender. (FAXED BIDS WILL NOT BE ALLOWED)

In order to assure your bid is fairly considered, it must be submitted in a properly sealed envelope, clearly marked on the lower left hand corner with the numbers "18-614-01". Bids that are unmarked or marked otherwise may be opened prematurely.

**SPECIFICATIONS:** The following items are minimum requirements and shall be provided whether shown as optional or standard equipment by the manufacturer.

**REQUIREMENTS: NEW 2016, 2017 or 2018 ASPHALT PAVER AND TRAILER**

1. Diesel engine with hydrostatic drive system
2. Six (6) ton asphalt hopper with front lip
3. Propane heating system
4. Paving width minimum of four (4) feet to maximum of thirteen (13) feet
5. Variable speed control
6. Self-adjusting steel track
7. Tongue pull with 2-5/16" inch hitch, tilt-bed seven (7) ton haul trailer with two seven thousand (7000) pound axles, electric brakes and spare tire.
8. Chains and binders
9. The bid shall include all delivery charges to site.
