- **13.Fire Chief's Report.-** Chief Freitag reported that it was time to build two small pump housings at Station #2, one for the sites water well that got destroyed during a storm a few months ago and the other for the pumps on the water storage tanks. Total Cost under \$8,000 this is an approved expenditure.

Financial Report EDS #8 July 31, 2024

- 1. Our July property tax deposit was \$4235.77.
- 2. The sales tax deposit was \$29,845.99.
- 3. As of August 26^{th,} our property taxes received in August have been \$2204.91.
- 4. Our August sales tax check was \$86,625.29. Of this amount, \$32583.45 was from regular sales tax collections and \$54,041.84 from state audits payments.
- 5. Our bank balance on July31st was \$307,329.73 and today we have \$395,744.43
- 6. The balance in the Contingency Fund is \$102,328.73.
- 7. The 4th quarterly payment to the Department has been made. The estimate for finishing our fiscal year is roughly \$425,000 in our operating account and \$102,000 in the contingency fund. We will provide the Department the 1st quarterly installment for operating funds in October which will leave us with approximately \$390,000.00 of liquid funds (including contingency) prior to the first payments of property taxes for FY 2024-25. Our sales tax payments have been averaging over \$30,000.00 per month
