

# BURNET COUNTY EMERGENCY SERVICES DISTRICT #8 SERVING BRIGGS/OAKALLA AREAS MEETING MINUTES OF JULY 22<sup>nd</sup>, 2024 @ NEBCFR STATION #1 LOCATED at 9111 FM 963, OAKALLA, TEXAS.

The following agenda items were discussed, considered and action take as appropriate.

#### AGENDA-

- Call to order and establish a quorum. A quorum was established of Commissioners Shamard, Keith Eide and Ewart. Commissioner Price was absent. Commissioner Shamard called the meeting to order @6:45pm.
- **2.** Pledge of Allegiance and Invocation. The Pledge of Allegiance was given by Commissioner Shamard and invocation by Deputy Fire Chief Travis Akin.
- **3. Recognition of Citizens and Elected Officials.** -Burnet County Commissioner Damon Beierle was present.
- 4. Citizen Comments on items not on the agenda: Individual members of the public may address the Board for a maximum of three minutes per person on items not on the current agenda for a collective total of 15 minutes. No formal action, discussion, deliberation, or comment by the board will be made for items not on the current agenda. None
- 5. Citizen Comments on agenda Items: Individual members of the public may address the Board for a maximum of three minutes per person, per item. Individuals may address the Board once per item. If a translator is required, the speaker and the translator are allotted six minutes per agenda item to address the Board. None
- **6.** Review posted minutes for additions or corrections and approve minutes from the June 24, 2024, Regular Meeting. Motion was made to approve the minutes from the June 24<sup>th</sup>, 2024 regular meeting by Commissioner Keith, 2<sup>nd</sup> by Commissioner Eide. Motion passed.
- 7. Review posted minutes for additions or corrections and approve minutes from the July 17, 2024, Special Call Budget Work Session. Motion was made to approve the minutes of the Special Call Budget Work Session by Commissioner Keith, 2<sup>nd</sup> by Commissioner Ewart. Motion passed.
- 8. Review posted treasurer's report for any questions and approval for the month of June 2024- Report is attached. Motion made to approve the June 2024 Treasurer's report by Commissioner Keith and 2<sup>nd</sup> by Commissioner Shamard. Motion passed.
- 9. Consider and take appropriate action on the following items:
  - A. Approve payment of regular bills. Carlton Law Firm \$385.50 and the quarterly payment to the department for \$128,147.50. Motion to approve the regular

bills was made by Commissioner Eide, and 2<sup>nd</sup> by Commissioner Shamard. Motion passed.

  - A. NBCFR Performance Measures Report Chief Freitag gave his report. He reviewed our accomplishment to date. See attached. No action taken
  - B. NBCFR Financial Reports- Chief Freitag gave his report. No action taken
- **11.Fire Chief's Report.** Chief Freitag gave his report. TCFP inspection is coming up. We are ready. The GAP and SWOT Analysis from the budget session will be added to future notes as it changes. See attached.
- **12.Adoption of Budget & Tax Planning Calendar**. Motion was made to adopt the Budget and tax Planning Calendar by Commissioner Shamard, 2<sup>nd</sup> by Commissioner Eide. Motion passed.
- 13. Consider and take appropriate action to adopt a budget for fiscal year October 1, 2024, to September 30, 2025.
  - A. **Operating Budget** motion to adopt a \$522,500 operation budget was made by Commissioner Ewart and 2nd by Commissioner Eide. Motion passed.
  - B. **Capital Budget** Motion to approve a Capital Budget of \$350,000 was made by Commissioner Shamard and 2<sup>nd</sup> by Commissioner Keith. Motion passed.
  - C. ESD Budget- No action was taken
  - D. Contingency Fund- No action taken
- **14. Discuss and consider a proposed tax rate.-** A Special Call Meeting was set for 8.5.2024 @ 6:45 pm at Station #1 to discuss and set the tax rate.
- 15. Consider and take appropriate action on the service delivery model for BCESD 8 and the contract renewal with NBCFR, a 501(c)3 organization, to include but not limited to:
  - A. Allowing the service contract to expire at the end of the term.
  - B. Request the name change of NBCFR, a 501(c)3 organization to Northeast Burnet County Fire Rescue Auxiliary.
  - C. Request the 501(c)3 charter be updated to a support role for the Northeast Burnet County Fire Rescue membership.
  - D. The creation and filing of documents and paying of fees to establish Burnet County Emergency Services District 8 DBA Northeast Burnet County Fire Rescue.
  - E. Authorize the creation and execution of a contract with Northeast Burnet County Fire Rescue Auxiliary.
  - F. Authorize surplus funding under the current contract to the 501(c)3 account.
  - G. Authorize the establishment of a bank account for the BCESD 8 operations budget.
  - H. Authorize the procurement of all required insurance coverages.

- I. Authorize the transfer of all assets to BCESD 8.
- J. Authorize the hiring of an accounting firm to manage the financial business and transactions of BCESD 8.
- K. Authorize the hiring of the current Fire Chief, Assistant Fire Chief and Deputy Fire Chief.
- L. Authorize the filing of any documents required for BCESD 8 to become a direct service provider.
- M. Authorize the transferring of any loans, agreements, utilities contracts and services to BCESD 8.
- N. Authorize the procurement of a fuel card and credit card account.
- O. Authorize the BCESD 8 President to brief the Burnet County Commissioners Court on the change that will be occurring and highlight key accomplishments. Motion to approve items A through 0 was made by Commissioner Keith, 2<sup>nd</sup> by Commissioner Ewart, motion passed. This motion confirms that Burnet County ESD #8 will be a direct provider for 911 first response, fire rescue.
- 16. As allowed by Texas Government Code 551.074: (a)-2. Burnet County ESD #8 board of commissioners will go into a Closed Meeting to discuss personnel matters. N/A no closed session occurred.
- **17.Set the date, time and location for the next ESD #8 board meeting:** The next meeting will be on Monday August 26, 2024, 6:45 PM, at the Northeast Burnet County Fire Rescue (NBCFR) Station #2, 2285 US 183 Bertram, TX.

- 1. Our June property tax deposits totaled \$7935.60, and the sales tax check was \$37,789.22.
- 2. As of July 22nd, our BCAD property tax deposits for this month have been \$4235.77 and we have received \$29,845.99 from sales taxes.
- 3. Our bank balance June 30th was \$401,395.47. Today the ESD has \$435,477.33 in the Operating Fund.
- 5. Our contingency account balance as of June 30th (and today) is \$102,285.99.
