The job was the same in the two periods. The Texas Legislature changed the name and increased funding in 2009. Established Texas' first statewide indigent defense system. Assisted counties create approximately 100 state-funded cost-effective legal representation programs including programs for appeals, veterans, juveniles, and people with mental health issues.

- Set agendas and action items with the board's grants and budget committee chairman, including
 coordinating public open meeting notices, drafting proposed motions, and publishing board meeting
 materials.
- Managed grant program distributing up to \$45 million per year to all 254 counties.
- Established and approved program grant budgets and expense reports at the county level.
- Directed, evaluated, monitored, and reported on grant program activities to the public and elected officials.
- Collaborated with regional administrative judges, presiding judges, and local court officials to ensure compliance with legal requirements.
- Implemented Texas' first statewide web-based indigent defense financial reporting and grant application system and created processes for classifying, approving, and monitoring grants and expense reports.

Planned and implemented with judges, attorneys, child advocates, and other stakeholders a new program to improve court processes and life outcomes for over 30,000 abused and neglected children in permanent state custodial care and the additional tens of thousands under court supervision.

- Led committee meetings, judicial roundtables, and assisted the court with Robert's Rules of Order in public meetings.

Monitored daily prison emergency activity reports for potential risks and directed legal responses.

 Managed connectivity and coordinated prison movement of hundreds of inmates for Texas' first state, federal, and appellate courts using video conferencing to connect to nine selected prisons for evidentieary hearings.
