Update on Joppa Bridge

- Bridge marker dedication in 2017
- County later identified structural damage, bridge closed to public access
- Joppa community concerned about funding and getting repairs done, reaching out to BCHC for assistance

Minutes from January 2, 2024 were approved as published. Financial report reviewed by Treasurer.'

Gus Wilke Granite Yard, a detailed history provided by Florence Reeves and Bob Kent.

- Gustav (Gus) Wilke, a German immigrant moved to the United States in 1868, known as the builder of the state Capitol.
- Wilke also oversaw the construction of the Austin to Oatmanville (Oak Hill) rail line, as well as a branch line from burnet to Granite Mountain near Marble Falls, both of which were built to facilitate the transport of large quantities of limestone and granite needed in the construction of the Capitol.

Certified Local Government Grant (CLG) update by Lela Goar.

- Stringtown Cemetery was approved for CGL grant
- Undertold Marker application was approved by the Texas Historical Commission (THC)
- The Undertold marker grant request also includes the THC to consider approval of an Official Texas Historical Marker for the Undertold topic. A minimum 5 page history of Stringtown is required. This will assist the THC for the needed verbiage for the historical marker.
- BCHC members approved the grant to be accepted for the Stringtown Cemetery Undertold Marker.

Cookbooks and Bluebonnet Festival
